



## One Square Is Fair 2024-2025

The “One Square Is Fair” program rewards member clubs for supporting NNJSDA events by providing dues reductions the following year. For the dance season 2024-2025 (June 1, 2024 through May 31, 2025), the Executive Committee has established the following guidelines:

Clubs must have at least one square of official members who pay the admission fee in attendance at five of the scheduled NNJSDA dances. Clubs may complete the program twice in one dance season. For the Midterm Student Dance only, officially registered students may be counted with the club that sponsored the class.
